

2026 Girl Scout Cookie Program Parent/Guardian Responsibility Form

My Girl Scout has my permission to participate in the 2026 Girl Scout Cookie Program. I agree to accept payment responsibility for all cookies received and to ensure my Girl Scout has adult supervision at all times.

The Cookie Program begins with preorders on **Tuesday**, **January 6**, **2026**, while girl delivery and cookies inhand sales begin on **Sunday**, **January 25**, **2026** and ends on **Sunday**, **March 15**, **2026**. Girl Scouts and troops will not receive credit for orders placed before or after the Program. Girl Scouts do not collect money or deliver products for direct ship orders.

I agree to the following:

- √ My child is currently registered as a Girl Scout for the 2025-2026 membership year.
- √ My Girl Scout and I will sign the <u>Girl Scout Internet Safety Pledge</u>.
- $\sqrt{}$ No cookie orders will be taken or sales made prior to Tuesday, January 6, 2026.
- √ Girl Scouts may market to customers in person within the Council's zip codes only (except for family members, friends and parent/guardians' co-workers).
- √ There is no jurisdiction for online sales, but Girl Scouts cannot have customers pay online except through Digital Cookie online sales system.
- $\sqrt{}$ Payment is collected from customers when products are delivered.
- √ I will accept responsibility for all cookies received and understand cookies cannot be returned unless it is damaged.
- √ I will obtain signed receipts for all cookies received/exchanged and for money submitted to the troop/group.
- √ My Girl Scout and I will follow <u>ALL</u> Girl Scout Cookie Program guidelines.
- $\sqrt{}$ I will submit cookie money to the Troop/Group Cookie Coordinator by the troop deadlines.
- $\sqrt{1}$ I understand that troop funds belong to the troop, not to an individual Girl Scout.
- $\sqrt{}$ I understand all cookies must be paid for no later than **March 17, 2026.**

In consideration of my Girl Scout being permitted to participate in the Cookie Program , I (we) hereby release, waive, discharge and covenant not to sue the Girl Scouts of Orange County, its directors, officers, employees, volunteers and agents (collectively the "Council") from any and all liability to myself or my child for any loss or damage, including property damage, personal injury, or death, whether caused by the negligence of the Council or otherwise, resulting from or related to my child's participation in the Event. I understand that all unpaid accounts may result in collection procedures.
