### Troop Instructions

Congratulations! Your Service Unit is participating in the Mega Delivery. Volunteers & staff will be distributing approximately 80,000 cases of Girl Scout cookies to 650 Troop. It's an awesome adventure and we thank you in advance for being prepared to help this process move smoothly!

### Recruit Volunteers

Recruit at least 2-3 **adult volunteers** to be your troop's loaders and counters.

- Each troop should recruit **2-3 adult or teen (16+) volunteers** to serve as **loaders and counters**.
- Volunteers must be physically able to lift up to **10 lbs** and able to see, hear, stand, and walk.
- **Drivers** must be **registered adult Girl Scouts** and must **remain in their vehicles** during pickup.
- **Loaders/Counters** do **not** need to be Girl Scouts; they may drive themselves, park, and walk alongside their troop's vehicles.
- **Only an adult passenger** in a pickup may exit the vehicle to assist.
- **No children under 16** or pets are allowed.
- Volunteers should **bring water** and **dress appropriately** for outdoor conditions.

### Prepare to Pick-up Cookies

- **Drivers** must be **registered and background-screened Girl Scouts**.
- Troops are **financially responsible** for their cookie order.
- Bring **enough vehicles** to collect the **entire order at once** (no RVs or motorhomes; U-Haul-type trucks are allowed). See chart on next page.
- Ensure **vehicles are fueled, cleaned out, seats down, and ready** before arrival.
- Bring a **copy of the Delivery Station Appointment Summary report**, which lists your troop's cookie order and pickup time.
- **Do not bring children, pets, or extra passengers**.
- Each troop vehicle must display a [Troop Dashboard Sign](#) with the **Service Unit and Troop number** written clearly with a Sharpie type marker.
- If loaders/counters are driving separately, they need a [Troop Helper Dashboard Sign](#) with the troop number written clearly with a Sharpie type marker.
- **Pickup is Saturday, Jan. 24** at your scheduled time, attendance is mandatory.

### Arrive During Your Cookie Pick-up Time

- Arrive **on time** with [Troop Dashboard](#) and [Helper Signs](#) clearly displayed on all troop vehicles.
- Enter through the correct Wild Rivers parking lot entrance; no left turns are permitted.
- All troop vehicles must arrive together; if one is late, all must exit and re-enter as a group.
- Drive slowly and follow all volunteer directions.
- At **Check-In**, receive your troop's **dot sheet** and instructions for entering the pickup lane.
- **Loaders and counters** will walk beside troop vehicles while loading; **drivers must stay inside vehicles at all times.**
- Troop loader/counter volunteers will **count and load** cookies. Ensure you have enough helpers.
- At **Check-Out**, a **registered and background-screened adult** must sign the **dot sheet** before leaving.
- If there's a **count discrepancy**, contact your **Service Unit Cookie Distributor** immediately.
- Expect the process to take **about 30 minutes** once in the pick-up lane, but **morning wait times may be longer.**
- Exit promptly once your order is complete.

Compact OR 3-Door	23
Hatchback or Small Wagon	25-30
Mid-Size Sedan (using back seat & trunk)	35
8 Passenger Mini-van or Sport Utility	60
Full-sized Station Wagon	75
Standard Pickup Truck	100
Full-sized Van with Seats	150
Full-sized Van without Seats	200
<i>All figures are approximate with the vehicle empty, using all space except the driver's seat</i> RV/Motorhomes are not permitted at Mega Delivery.
