- **Advertising:** Distribution of handbills requires a special permit.
- **Second-Hand Dealers:** A special permit is required for anyone dealing in antiques or other previously owned merchandise.
- **Sidewalk Sales:** A Temporary Use Permit is required for use of public sidewalks to conduct an merchandising activity.
- **Refunds:** Payee is not entitled to a refund of any portion of the tax by rason of termination of business prior to expiration of the term for which the certificate was issued.
- **Renewal:** The business owner is responsible for timely renewal. Delinquent fees must be added if payment is not received later than the expiration date. Not receiving a renewal notice, for any reason, does not relieve responsibility for timely payment.
